Seven Executive Members

General rules apply for common effect on the election procedure in pursuant to the rules directed in the constitution:

- Nomination papers will be available from 16 September, 2012 and will be collected from the undersigned Returning Officer (102 Minto Road, Minto).
- Nomination paper must be signed by two eligible members of the Centre and accompanied by the written consent of the candidate.
- Nomination paper must be received by the undersigned Returning Officer at 102 Minto Road, Minto at least 72 hours before the starting time of the Annual General Meeting of the Centre (i.e. by 4.00 PM of October 04, 2012).
- Nomination paper will not be accepted for any delay/late submission and if name spelling and voter number are not same as voter list.

- Nomination paper can be withdrawn at any time before the Annual General Meeting start (4:00 PM of October 07, 2012) by submitting written application by the candidate.
- Returning Officer's decision will be the final verdict on any dispute, conflict, contradiction and issues on the election business which is not specifically or clearly directed in the constitution to avoid any serious dilemma on the issues.
- If valid nomination is not received within the time frame for any portfolio, the Returning Officer's decision will be announced and action will be taken as directed by the rules in constitution.
