Proxy Instructions:

Allocating preferences for voting:

Signing the form:

The proxy form must be signed by the person registered as a member personally, or by a duly appointed attorney or agent. If a proxy is executed by an attorney of a member, the attorney must declare that the attorney has no notice of revocation of the power of attorney and the relevant power of attorney, if it has not already been noted by AMWC, must accompany the form of proxy.
